1/29/15	GAF	Boilermaker	Sprain, Strain, Torn	Ankle	At approximately 7:40AM, a boilermaker was spotting an aerial lift while the operator was backing to the east on the east side of Unit 4. While spotting the boilermaker was standing on the top lid of the fire protection structure at this location. As he stepped down off of the south side of the structure he rolled his ankle & fell to the ground. The boilermaker was taken to the URS first aid office for observation / treatment. First Aid treatment was provided at that time. Due to the amount of swelling & to rule out any potential broken bones in the ankle / foot an appointment was made at the local clinic.
